NOW THIS AGREEMENT WITNESSETH AND IT IS AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

- 1) E-commerce aggregator services are offered by ABE under the plans listed on the website. These plans may vary from time to time.
- 2) Verifying companies/brands/dealers and distributors' claims requires companies/brands/dealers and distributors to submit certification/trading documents.
- 3) As soon as registration and verification have been successfully completed, companies/brands will be provided with a dashboard where they can begin listing their products.
- 4) It may take up to 3-4 days for verification of the documents/ certifications (for example, FSSAI...etc.).
- 5) **ABE will take care of shipping charges irrespective of the location and order quantity * except on the return of the product *.**
- 6) Following the successful delivery of the product, the payments will be automatically deposited into the bank account of the company given during the registration process upon request from Vendor Dashboard. This process usually takes 7-10 days from the delivery of the product and has a minimum withdrawal limit of ₹5,000. In case of any return this may take longer than usual.

- 7) In the event of any issues with the product quality, the brand will be held solely responsible.
- 8) Any company/brand/dealer or distributor can change its prices and offer a discount at any time without any prior notice to ABE.
- 9) Companies/brands/dealers and distributors found to be violating the terms or using malpractices to gain the trade advantage will be blacklisted and ABE can take legal action in such cases.
- 10) When a product is returned due to quality issues, the companies/brands/dealers and distributors are responsible for the delivery, return and packing charges.
- 11) It is recommended that companies/brands/dealers and distributors shall not accept returns on products that are in combination.
- 12) Listing of products by Brands is free of cost . ABE provides product listing services at a minimal charge of *₹2500/100 products in cases where companies are unable to list products on Organic Orion Dashboard.(Note:- Companies/brands/dealers and distributors must provide all product details and pictures.)
- 13) For companies/brands/dealers and distributors who are interested in working with ABE but cannot provide sufficient product details and photos, they are required to provide the product samples in good condition for product photography (NON RETURNABLE) in the name of ABE. In such cases, *₹250 will be charged per product that includes the product pictures and service cost to list the products. Companies, brands, distributors, and dealers are still required to describe their products in English.
